# The Confluence Collective Photo Archive policy

# 1. Free Access for Local Researchers

Local researchers from the Darjeeling Hills and Sikkim are granted free access to the Archive for non-commercial purposes such as academic research or personal use.

# 2. Commercial Use Policy

For any commercial use, including but not limited to publishing, exhibitions, advertising, or other revenue-generating activities, a usage fee will be applicable. The fee structure will be determined based on the nature, scope, and scale of the project.

# 3. Mandatory Photo Credit

All users must provide appropriate credit to The Confluence Collective and the respective contributor of the image(s). The credit must state:

"Photo courtesy: [Name of Contributor]/TCC Photo Archive."

# 4. Approval and Licensing

Prior written approval is mandatory for all uses of the images, whether for non-commercial or commercial purposes. Users may be required to sign a licensing agreement specifying terms of use and restrictions.

## 5. Non-Exclusive Licensing

The Archive grants non-exclusive licenses for approved uses. This means that the same images may also be licensed to other parties.

## 6. Prohibited Uses

The Archive's images may not be used in:

- Contexts promoting hate speech, discrimination, or political propaganda.
- Any activity that violates local or international laws.

## 7. Reproduction Limitations
